1. What personal information we collect

In general, you can visit our Site without telling us who you are or revealing any Personally Identifiable Information. Personally Identifiable Information means information that lets us know specifically who you are.

If you wish to download practices from our site, you must create an account. During account creation, we collect the following Personally Identifiable Information: your name and email address. If you order a physical we product, we collect a shipping address. When you place an order (including free downloads), we keep a record of the products you ordered.

When you sign up to receive our monthly newsletter, we collect your name and email address. You do not need to create an account to sign up for the newsletter. We keep a record of which newsletters you have received.

All of our monetary transactions are processed via PayPal; we do not collect or store credit card information. When you enter information on the PayPal pages, please refer to the PayPal privacy policy.

2. How we use your personal information

We use your name and email address to deliver your order to you, to communicate with you about the status of your order, and to send you our monthly newsletter (from which you may unsubscribe; see below).

We use your shipping address to ship physical products to you. We do not send any other physical mail

4. Who we share your personal information with

We do not sell, trade, or rent your Personally Identifiable Information. The only cases in which we would transmit your Personally Identifiable information to a third party are outlined in the following paragraph. Otherwise, we do not share it with anyone.
